FLYING INSECTS

Clothes Moth: Spray storage shelves, drawers, wardrobes. Clothes should be removed before spraying.

Flies and Mosquitoes: Spray short burst (1-2 seconds) in direction of insect. Spray onto surfaces where mosquitoes and flies land or roost.

Wasps and Flying Ants: Spray wasps and ants directly or spray where they land or roost.

CRAWLING INSECTS

Ants: Spray around and in garbage bins, food disposal areas and entry points.

Carpet beetles: Spray carpets and rugs, particularly under furniture and other objects. Spray also skirting boards and inside cupboards and other storage furniture.

Cockroaches: Spray skirting boards, and under and behind cupboards and appliances where cockroaches hide or spray a barrier around inaccessible infested areas.

Fleas: Treat infested carpets or rugs by thoroughly spraying to cover entire surface. Ensure ventilation is adequate.

Silverfish: Spray around bookshelves and in drawers where silverfish hide. Spray architraves and skirting boards to create barriers to movement.

Slaters and Millipedes: Spray directly on slaters and millipedes or in obvious entry points into the house doorsteps, window sills and cracks and crevices.

Spiders: Spray around eaves and wherever webs are found.

Re-apply when pests reappear
